SIR GUY CONTEST RULES

1. The Jet Chapter Knights of Mantra Sir Guy contest will be held on **Saturday April 3, 2010 at The Cuff Complex.**
2. Each contestant may enter into one of **two leather attire categories.** Contestants should stay within the attire category chosen for the length of the contest. You will be judged on this.
3. **Categories for Sir Guy are:**
 - a) Leather - FULL to be dressed in full leather: Jackets, shirts, pants, boots, caps, etc. to Be of leather.
 - b) Leather - GENERAL may be dressed in partial leather: Contestant's discretion.
4. **There will be three (3) entrances for each contestant:**
 - a) Leather attire.
 - b) Performance of either leather fantasy or lip-sync a song of your choice.
 - c) Least but legal attire. (This must be street legal according to the law) No Nudity!
5. **Props may be used if carried.**
6. **Sir Guy** and the **first** and **second runners up** will be selected from the finalists of all categories.
7. **Contestants will abide by the "WAC 3 14-16-125 Suggestive, lewd, and/or obscene conduct code" set forth by the state of Washington.**
8. A contestant's consent form must be signed and turned in to the contest Coordinator prior to the competition.
9. Judges will be selected prior to the competition. Jet Chapter Knights of Mantra, Seattle, current members are excluded from judging.
10. The emcees or judges during any or all of the contestant entrances may ask questions.
11. **A one- (1) minute address to the audience** will be included in the first or leather attire walk on.
12. You must be twenty-one (21) years of age or older to enter this contest. The contest coordinator may require proof of age.

Sir Guy will receive a plaque for personal display, a medallion for personal use or display, a T-shirt, plus a grand prize.

First runner up to will receive a plaque for personal use or display and a prize.

Second runner up to will receive a consolation gift.
